ACCREDITATION CARDS	If you pay by bank transfer, the weigh-in cards will be sent as a PDF by e-mail in the week before the competition. The digital version of the start card is then sufficient on site at the scales. A separate registration on site is not necessary. The transfer must be received by us by 09.10.2024 at the latest.  If paying in cash on site, personalized weighing cards are purchased at the cash desk, which the athletes must show at the scales.  All weighing cards must be checked for errors upon receipt. Later complaints can delay the competition enormously.
